- b. To ratify a decision made by the Clerk in consultation with the Chairman to instruct a tradesman to make necessary repairs to the chamber and manhole surrounding the pipework found to be leaking. That expenditure of £203 be approved for this purpose. (Fin Reg 4.5 refers).
- c. To ratify a decision made by the Clerk in consultation with the Chairman to purchase a battery and pads for the defibrillator at Small Banks. That expenditure of £396.72 (incl VAT) be approved for this purpose. (Fin Reg 4.5 refers)
- d. To consider a request from Burley Parish Council to contribute up to £691.20 toward the Duke of Edinburgh scheme running costs. Scheme was taken over by Burley Parish Council from Bradford in 2018 to avoid losing the local provision. 10 young people from Addingham are currently registered.
- e. To approve a scheme of delegation to the Clerk in order that invoices for August and September due for payment before the next meeting on 20th September are paid in accordance with fin reg 5.5.
