Resolved

That an objection be sent to the planning authority in response to the consultation on the application to the effect that the plans represent excessive development of a small site with limited access. The access road is narrow and only partially adopted and the build will require large commercial vehicles to travel in and out of an existing housing development. Council shares the view of the Highways officer who has concerns regarding the number of dwellings serviced by a narrow private drive.

Council has concerns about the footprint of the proposed side extension and its proximity to Street House Farm, which is a listed building. Not only will the new building be closer but the proposal to sweep the driveway across the current boundary of that property will certainly detract from its character and Heritage value.
