

The Addingham Parish Council meeting held on Monday the 9<sup>th</sup> June 1947

26 Proposed by Cr Cockshott seconded by Cr Adams that the minutes of the previous meeting be signed

27 The Chairman reported that the sub committee appointed to meet the Transport Manager of the West Yorkshire Road Car Co Ltd on the 20<sup>th</sup> May 1947 had come to the conclusion that the Bus Company were doing all in their power to cope with the Bus passengers between Addingham and Ilkley, and especially so in view of the fact that 50% of the Buses needed a thorough overhaul. It was also pointed out that New Buses were on order but it may be months before they are delivered.

28 Telephone Kiosk Smallbanks Cr Smith reported that he hoped to collect £20 from the inhabitants of Smallbanks and he would hand same over to the Parish Council in order that the Post Office Telephone may be reimbursed for the initial outlay on the proposed Telephone Kiosk at Smallbanks.

29 Garth Bridge It was resolved that we write the West Riding County Council intimating that we propose to carry out the repair of the Garth Bridge Bolton Road and ascertain if we are in order

30 It was resolved that we write the Skipton Rural District Council with reference to a style at Storiths which is impassible in consequence of the wall adjoining same having collapsed and ascertaining what steps should be taken to make the owner rebuild the wall.

31 In consequence of the site for a Telephone Kiosk at the Green not being approved by the Rural District Council the Council suggested either Heathness at the bottom of Moor Lane as an alternative.

32 It was resolved that we write the Rural District Council reporting the complaint signed by several persons complaining of the state of Moor Lane and expressing the opinion that the same should be remedied without delay

34 Extra Cleaning Old School alterations It was resolved that Mrs Stella Pegg be given a gratuity of Two guineas for cleaning the Old School during and after the alterations.

35 It was resolved that the Clerk ascertain if the Council would be in order paying one years rent as compensation to Mr J Cockshott should they decide to terminate his tenancy at Stamp Hill.

36 Storm Waters & Sewerage system It was resolved that the Rural District Council be notified of the Sewers being unable to cope with Storm waters especially at the lower end of the village and instruction them to take immediate steps to prevent the recurrence of Sewage oozing out into the roads & surface as had occurred during the recent storms.

37 It was resolved that the question of the poor gas supply in the Village be left over until the July meeting of the Council
