53 Minutes It was resolved that the minutes of the previous meeting be signed

54 Lawn Mower repair The Clerk reported that the repairs to the Lawn Mower would take at least 15 days and that no estimate of the cost could be given unless the Mower was sent to the works for examination. It was resolved that the matter be left over until the end of the season

55 Equipment for Children's Recreation Ground It was resolved that we furnish the Chief Education Officer with a schedule of the present equipment on the Recreation Grounds and ascertain the additional equipment necessary in order to obtain a Grant

56 Bus service improvement A letter was considered from the West Yorkshire Road Car Co Ltd with regard to the Council's application for an improvement in the Addingham Bus Service and it was resolved that we point out that the most important improvement necessary was in the Skipton Harrogate Service

57 Extra Cleaning Caretaker It was resolved that a gratuity of £2.2.0 be granted for Extra cleaning to the Caretaker Mrs S Pegg and that the West Riding County Council be approached with regard to an amendment in the amount of the Salary in respect of the work in connection with the Library

60 Addingham War Memorial A letter was read from the Addingham Branch of the British Legion complaining about the condition of the Memorial in general and suggesting the same could be made a credit to the Village on Remembrance Day

61 Alterations to War Memorial A tender for the complete work of the alterations to the Memorial had been received amounting to £97.15.0 and it was resolved that the Chairman approach subscribers and invite subscriptions towards the cost which could be handed to any member of the Council

It was also resolved that the Tender of Mr L T Learoyd for the alterations amounting to £97.15.0 be accepted
