103 Clerks Salary The salary of the Clerk be paid in respect of the full year to 31<sup>st</sup> March 1949

104 State of Main Street Concern was raised as to the state of Main Street owing to five manholes being between 3" to 6" below the surface and it was decided to draw the attention of the West Riding County Surveyor to this matter

105 Bus Stops The Bus Stops at Adelaide Terrace was considered to be an inappropriate stopping place and the West Yorkshire Road Car Co Ltd be requested to remove same

106 Clerks Illness It was unanimously agreed that a letter be sent to Mr Mitton expressing the Council's wishes for a speedy recovery
