

At a Meeting of the Addingham Parish Council held on Monday 14th March 1949

107 It was resolved that the minutes of the previous meeting be signed

108 Matters Arising War Memorial Cr Hadley reported that together with Crs Walker, Watson Mrs Ives and the Chairman he had interviewed Mr Ernest Roe with a view to engaging him for approximately two days per week to keep the grounds cleaned and in proper condition.

Cr Watson moved and Cr Smith seconded that Mr Ernest Roe be engaged for a period of twelve months commencing from 14th March 1949 at £2.10.0 per week

109 Use of Room A letter was submitted from the WRCC Education Department Skipton asking for the use of the room on 8th April and it was agreed for them to have use on the usual conditions

110 Towns Well A letter was submitted from Mr EH Wood Small Banks Ilkley asking if he could contract to keep clean the Town's Well as his father had previously done

It was resolved that he be engaged for the work and be paid £1.0.0 per annum

111 Road Safety Cr Hadley asked if it were possible to use the Library for advertising the coming Pedestrian Crossing Week and as this is in the occupation of the WRCC he was directed to address his enquiry to that authority

112 Robots Cr Hadley reported that tenders for the erection of robots had been accepted in July last and it was unanimously resolved that the WRCC be asked when they may be erected

113 Gas Supply It was reported that the gas supply in the Moor Lane district was of very poor quality and instructions were given that the Ilkley RDC be asked if it is possible to improve the supply

114 Allotment Rents The Acting Clerk reported that various people being Tenant of allotment have stated that arrangements had been made with Mr Mitton the Clerk for non payment of allotment rent owing to their carrying out certain repairs and work viz:-
