

The Addingham Parish Council meeting held on Monday the 23<sup>rd</sup> May 1949

Appointment of Chairman for the ensuing year It was resolved that Cr Adams be appointed Chairman for the ensuing year

Minutes It was resolved that the minutes of the previous meeting be signed

Apologies Apologies for absence were received from Cr JB Ives and Cr Mrs Ives

Delay in delivery of Telegrams A letter was submitted from the Head Postmaster Bradford asking for further particulars regarding the delay in the delivery of telegrams in Addingham and the Clerk was requested to reply thereto

Allocation of Council Houses A letter was submitted from Mr LR Wood who referred to his claim that he should be allotted one of the new Houses and leaving the decision to this Council It was resolved that the letter be referred to the Housing Committee of the Skipton Rural District Council

Bus Service A letter was received from the West Yorkshire Road Car Co Ltd stating the Traffic Manager could meet the Council after the 25<sup>th</sup> May. It was resolved that a deputation consisting of the Chairman & Cr Walker should arrange a conference for Tuesday the 31<sup>st</sup> May 1949 at 2 pm and press for a half hourly service to and from Keighley

Street Lighting A letter was submitted from the Engineer & Surveyor of the Ilkley Urban District Council stating that he was now responsible for the Street Lighting and the normal service usually ceased at the end of May and he desired to ascertain if this Council desired any change. It was resolved that the 4 junction lamps be lighted all night during the Summer months and the remainder be unlit and the Clerk was instructed to inform the Surveyor accordingly

Addingham War Memorial A letter was submitted from Messrs Wright & Sons Ltd Monumental Sculptors offering to thoroughly scrape and clean the present slab of the Addingham War Memorial also regild the letters of the Inscription and names for the sum of £45 (fortyfive pounds) net. If the letters of the inscription and names were drilled and leaded instead of gilded including the scraping and painting of the slab the price would then be £64 (sixtyfour pounds) net

After careful consideration it was decided to take no further action in this matter for the present

Appointment of Vice Chairman It was resolved that Cr Hadley be appointed vice chairman for the ensuing year

Appointment of Treasurer It was resolved that Mr H Evans of Lloyds Bank Ilkley be appointed Treasurer for the ensuing year

Committee It was resolved that no Committee be appointed

Day of Meetings It was resolved that the Council meet on the 2<sup>nd</sup> Monday in each month at 8pm **193**

Declaration of Office All the members present agreed the Declaration of Office

Concrete pitches for Recreation grounds It was resolved that enquiries be made to ascertain the grants available for concrete pitches on Public Recreation Grounds and that estimates of the cost of laying same be obtained

Provision of Jungle gym & See Saw at Memorial Ground It was resolved that enquiries be made from the WR Education Officer to ascertain the position and also when would the equipment be erected in the Memorial Close Recreation Ground
