

The Addingham Parish Council meeting held on Monday the 11<sup>th</sup> July 1949

It was resolved that the minutes of the previous meeting be signed

**Street Lighting** A letter from the North Eastern Gas Board stating that it was their intention to review existing contracts and arrangements with regard to Street Lighting was considered. It was resolved that the Board be asked to give some idea what the charges were to be if they contemplated varying same

**Bowling Green** A deputation of 2 members from the Addingham Bowling Club attended and offered to use some of their funds for improving the condition of the Bowling Green at the Memorial Close provided they could have the free use of the Green during the years 1949, 1950 & 1951, allowing the Public reasonable facilities for Bowling if necessary. The deputation pointed out that it had been derelict for some years and they were anxious to assist the Council to restore same. The Council informed the deputation they had every sympathy with their suggestion and thanked them for their offer and promised to interview the deputation later in the evening

**Concrete Cricket Pitches** It was resolved that a letter be forwarded to the West Riding Playing Fields Association regarding the laying of Concrete Cricket Pitches and whether any Grants are available as any hope of assistance from the Don Bradman Fund is extremely unlikely

**Local Feast Holiday** It was resolved that the Head Postmaster be informed that this Council concur in the proposal to close Addingham Post Office on Monday and Tuesday the 25<sup>th</sup> & 26<sup>th</sup> July being the Local Feast Holiday

**Addingham C of E School Managers** It was resolved that Cr JB Ives be appointed the Council's representative on the Body of Managers of the Addingham C of E Primary School his term of office expiring on the 31<sup>st</sup> July 1952

**Memorial Hall Ladies Conveniences** It was reported that the Ladies Conveniences at the Memorial Hall had been repaired and was now serviceable

**Public Conveniences** It was resolved that the Skipton Rural District Council be asked what the present position is regarding the provision of Public Conveniences in Addingham and when it is expected they will be in use

**Old Folks Club Room** It was resolved we write the West Riding County Council regarding the provision of a Club room in Addingham for the Aged

**Road Signs** It was resolved that the West Riding County Council be written regarding the removal of the studs in the Road at Bark Hill Top

**Village Doctor** The Council confirmed the Chairman's action on the 21<sup>st</sup> June 1949 in pressing for the selection of a resident Doctor in Addingham as it was

found there would be no Doctor in the village owing to the present one having been called up for National Service
