Memorial Plaque Fund A further gift of £5/5- had been received from Wesley Place Chapel.

Straight Lane It was resolved we write the Skipton Rural District Council to ascertain why the Highway authority had only accepted liability to repair Straight Lane to Scar Ghyll no further

Traffic Signals It was resolved that we press the West Riding County Council to proceed with the construction of Traffic signals at Crown Corner forthwith as we consider it is time this work was completed

Damaged Fence near Suspension Bridge Cr Watson kindly promised to look into the question of the liability for the repair of this fence and would let the Council know the result of his investigations

Silsden Road Allotments It was resolved that Mr Hollingdrake be excused his rent at Silsden Road as he had repaired 12 yards of the wall

Damage at the Memorial Close Owing to the renewal of damage at the Memorial Close it was resolved that the Council would institute proceedings against future offenders and that the Police be notified

Bowling Green maintenance and offer of the Addingham Bowling Club to assist
The Chairman reported that the sub committee appointed by the Council had met Members of the Addingham Bowling Club and had agreed to the following procedure subject to confirmation in writing by the Addingham Bowling Club

1. The Addingham Bowling Club to share the cost of Weed Killer & seed
2. The Addingham Bowling Club to be responsible for the collection of greenage charges, keep daily records and hand over to the Council 50% thereof
3. The Addingham Bowling Club to allow the public reasonable facilities for access to the Bowling Green

Street Lighting by Electricity A letter was read from the Yorkshire Electricity Board sub area re the installation of Electricity for lighting the street lamps

instead of gas as at present. It was resolved owing to the rather complex position to ascertain the views of the Skipton Rural District Council as to the advisability or otherwise of proceeding with the scheme

Silsden Road Allotments Gate- new entrance to same The Council received an offer from Mr A Thompson to rent a portion of Silsden Road Allotments but a condition was that a new entrance would be necessary: In these circumstances it was resolved that we approach the West Riding County Council to ascertain if they would give their approval to a gate being erected on the Silsden Road side

of the allotments to give access thereto for Mr Thompson's timber wagons
It was further resolved that we write Mr A Thompson explaining the procedure involved when a new entrance is contemplated to property adjoining a public highway

Offensive smell Bark Hill Top Untidy & unsafe Street It was resolved that we write the Skipton Rural District Council complaining about the offensive smell from a Manhole at Bark Hill Top, and would they proceed to abate same; also that the sweeping of the street appears to have been neglected and they should be swept often and kept more tidier in the future

Provision of seats to Farfield Hall It was resolved that the West Riding County Council be approached with regard to the provision of one or two seats from Addingham to Farfield Hall as it was felt they would be appreciated by the residents there when walking to Addingham which is the nearest village and 1¼ miles away

Road to the New Council Houses It was resolved that we write the Rural Housing Authority regarding the width of the present highway to the New Council Houses which could not cope with the traffic including a bus and asking them to state whether it was proposed to widen the approach in the immediate future or alternatively schedule same for one way traffic

Agendas It was resolved that items for the Agenda at Council meetings be left at the Old School 4 days before the making in order that the Members of the Council may be notified thereof. The Chairman however to have the right to use his discretionary powers to allow urgent matters to be considered at the meetings
