Traffic Signals A letter was submitted from the West Riding County Council stating the provision of Traffic Signals owing to the immunity of accidents was not recommended in the 1949/50 estimate. It was resolved that the West Riding County Council be asked to treat same as a matter of urgency as the traffic was exceptionally heavy at the weekends and it was absurd to wait until a disastrous smash occurred before providing Traffic Signals
