Approach to New Council Houses. Arising out of a letter received from the Clerk of the West Riding County Council it was resolved that a satisfactory solution may be reached if a deputation met this Council on the Burns Hill Housing Estate

Review of Footpaths. Arising out of a letter received from the Clerk of the Skipton Rural District Council it was decided to have the review of footpaths in abeyance for the time being

Minutes. It was resolved that the minutes of the previous meeting be signed

Housing Complaints. It was resolved that the Skipton Rural District Council's attention be drawn to the persistent complaints from the tenant of No.6 Burns Hill regarding a smoky chimney and will they remedy same forthwith

Bad timing of 7.30am Bus to Ilkley. It was resolved that the West Yorkshire Road Car Company's attention be drawn to late starting of the 7.30am bus to Ilkley which fails to connect with the 7.45am Ilkley to Bradford Bus and suggesting it would be very much appreciated if the Bus could be retimed to 7.25am as it would also link up with the 7.40am Ilkley to Leeds Bus

Old School Lettings. Arising out of a letter received from the Registrar complaining that the proposed charge of 4/6 per Session for the use of the Old School was higher than usually paid by The West Riding County Council, it was resolved that 25/- for 6 sessions was the only reduction this Council could agree to

Overhanging Hedge Bark Hill Top. It was resolved that the West Riding County Council's attention be drawn to the Hedge at Bark Hill Top which overhangs the road and is dangerous to traffic

Restriction of Street Lighting. It was resolved that the circular letter received from the Ministry of Transport regarding curtailing street lighting be laid on the table

Lease of Basement of Old School for Library purposes. It was resolved that we agree to the present lease of the ground floor to the West Riding County Council for a Library being amended but not to a new lease for 5 years and that we write them accordingly

Provision of Litter Baskets. It was resolved that we write the Sanitary Inspector suggesting Litter Baskets should be fixed at the following points

Bark Hill Top

Traffic Signals Bolton Road. A letter was read from Capt.GB Drayson M.P stating

that he was taking up the question of Traffic Signals with the Ministry of Transport and would communicate with us again shortly

Straight Lane. A letter was read from Capt. GB Drayson M.P. regarding Straight Lane stating that as a Member of Parliament he had no legitimate method of communication with the West Riding County Council. If we wanted to bring pressure on the West Riding County Council he was afraid we must do so through the Local representative on that Council
