

The Addingham Parish Council meeting held on Monday the 12th March 1951

Approach to New Council Houses. Arising out of a letter received from the West Riding Council regarding the extension of the New Road on the Burns Hill Estate stating that a deputation would meet this Council it was resolved that Cr Walker Cr Lumley Cr Hadley form this Council sub committee

Footpaths survey. Arising out of a letter from the Skipton Rural District Council regarding the Footpaths Survey it was resolved that the West Riding County Council's officials complete the Schedules etc from the Ordnance Map which shows the footpaths in red ink which was marked by the Parish Council some years ago

Lease of Old School for Library. Arising out of a letter received from the West Riding County Council regarding the proposed new Lease to cover the whole of the Library premises it was resolved that the new lease be approved for 5 years and that the existing tenancy agreement be cancelled

Minutes. It was resolved that the minutes of the previous meeting be signed

Resignation Councillor Whittaker. Arising out of the Chairman's information that Cr J Whitaker had resigned his office of Parish Councillor it was resolved that we regret his decision to resign and the circumstances which prompted him to do, at the same time the members wish to place on record their appreciation of his service and help during his term of office

Parish Council Vacancy. It was resolved that Mrs E Lumley be invited to fill the vacancy on the Parish Council

Telephone Deposit for Smallbanks Kiosk. A letter having been received from the Telephone Manager stating that Deposits for the installation of the initial outlay on Telephone Kiosks will not be payable in respect of Smallbanks on the authority of the Postmaster General it was resolved that the sum of £20 lodged for upkeeping be refunded to Cr Smith

Cr Smith regretted he would not accept same as the list of subscribers had been mislaid (Minute 28 (1947) 135)

It was therefore resolved that this Council advertise the Local Press asking depositors to kindly notify the Clerk of the amount of their contribution towards the deposit of £20

Public Conveniences. Arising out of a letter received from Skipton Rural District Council pointing out that the Owners were unwilling to sell the site for Public Conveniences recommended by this Council and in consequence compulsory order for purchase would have to be obtained it was resolved that the site near the Old School was the most suitable and that the compulsory order be applied for without delay

Tipping on Druggist Lane. It was resolved that the Sanitary Inspector's attention be drawn to the tipping of refuse in Druggist Lane near the Liberal Club

Repair of Gates Tip Silsden Road. It was resolved that the Gates on the Silsden Road Tip were in need of repair and it was decided to draw the attention of the Skipton Rural District Council to same

Proposed New Entrance Silsden Road Allotments. The Town and Country Planning Committee having raised a query regarding development value it was resolved that the appropriate forms be completed

Tenders for Parish Lands. It was resolved that following Tenders for Parish Lands from 1st April 1951 to 30th March 1952 be accepted
